The DOE is asking for comment from stakeholders to inform its energy storage SRM through a formal Notice of Availability (NOA). The DOE released its draft Energy Storage Strategy and Roadmap(SRM),providing direction and opportunities for energy storage investments.

Does the energy storage strategic plan address new policy actions?

This SRM does not address new policy actions,nor does it specify budgets and resources for future activities. This Energy Storage SRM responds to the Energy Storage Strategic Plan periodic update requirement of the Better Energy Storage Technology (BEST) section of the Energy Policy Act of 2020 (42 U.S.C. § 17232 (b) (5)).

Why should we invest in energy storage?

The SRM cites the underlying motivation for investment in energy storage as ensuring "that the American people will have the resources needed,when needed." "1. To facilitate safe,beneficial,and timely deployment of energy storage technologies and accelerate the development of new technologies that address current and emerging consumer needs. 2.
